Part	Contents	Elaboration
Part I	The Union and its territory	Part I defines the territory of India and includes provisions regarding the names and territories of states and union territories. Articles 1 to 4 deal with these aspects.
Part II	Citizenship	This part outlines the criteria for acquiring and terminating Indian citizenship. It also discusses the rights of citizens and dual citizenship issues. Articles 5 to 11 elaborate on citizenship.

Part V	The Union	Part V describes the structure, powers, and functioning of the Union government, including the President, Vice President, and Parliament. Articles 52 to 151 elaborate on these aspects.
Part VI	The States	Part VI discusses the states in India, including the Governors, state legislatures, and the state executive. Articles 152 to 237 provide details about states' governance.
Part VII	States in the B Part of the First Schedule	Part VII includes Article 238, which pertains to the subordination of certain states, called "B States," to other states or union territories.
Part VIII	The Union Territories	Part VIII addresses the governance and administration of Union Territories in India. Articles 239 to 242 provide the framework for this governance.
Part IX	The Panchayats	Part IX deals with the establishment and functioning of Panchayats (local self-governance

Part IXB	The Co-operative Societies	Part IXB pertains to Co-operative Societies and their governance. Articles 243-ZH to 243-ZT provide details about the functioning of co-operative societies.
Part X	The Scheduled and Tribal Areas	Part X addresses the administration and governance of Scheduled Areas and Scheduled Tribes. Articles 244 to 244A elaborate on these provisions.
Part XI	Relations between the Union and the States	Part XI delineates the distribution of powers and responsibilities between the Union and the states. Articles 245 to 263 discuss these relations.
Part XII	Finance, Property, Contracts, and Suits	Part XII covers financial provisions, property rights, contracts, and legal jurisdiction. Articles 264 to 300A provide details in these areas.

Part XIII	Trade, Commerce, and Intercourse within the Territory of India	Part XIII deals with trade and commerce within India, ensuring free movement of goods and people. Articles 301 to 307 elaborate on these aspects.
