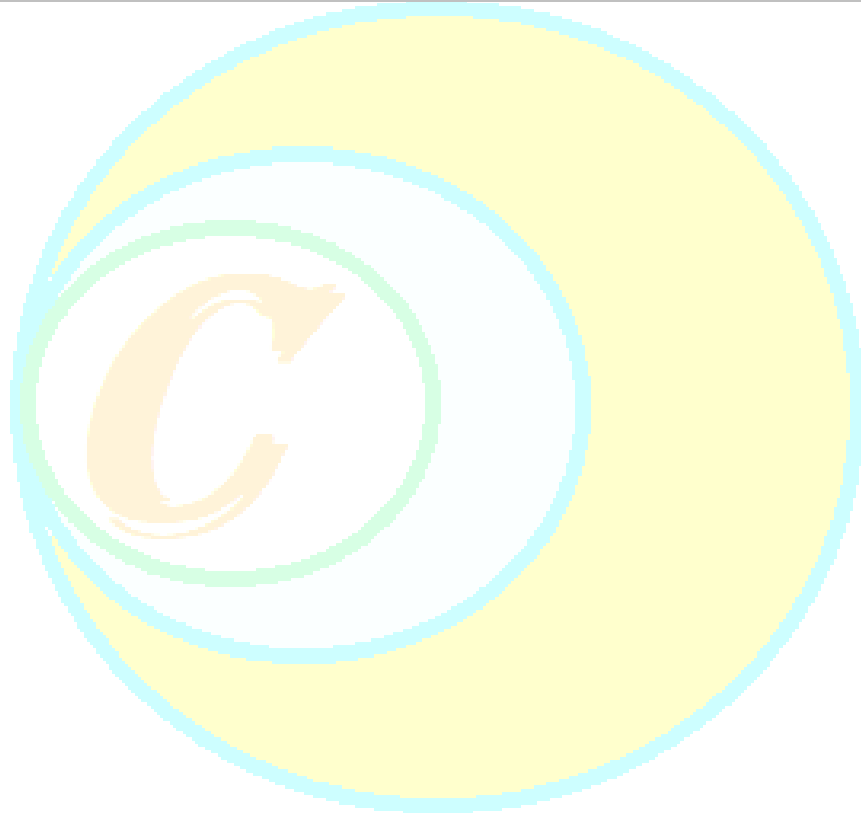


Importance and Criticism of Fundamental Duties
